

Register of Small Registered UK AIFMs (Updated 27th March 2024)

This register includes details of Alternative Investment Fund Managers that are registered as small registered UK AIFMs under regulation 10(1) of the Alternative Investment Fund Managers Regulations 2013 (SI 2013/1773). Small registered UK AIFMs are not authorised persons as a result of their registration as small registered UK AIFMs and are not included on the Financial Services Register in relation to this business. However, small registered UK AIFMs are not prevented from carrying on regulated activities as a result of their registration as small registered UK AIFMs and therefore may be included on the Financial Services Register in relation to other business.

Where a small registered UK AIFM manages an AIF it will not be authorised by the FCA or subject to FCA rules in relation to managing that AIF. This means that if you invest in an AIF which is managed by a small registered UK AIFM you are unlikely to receive the same level of investor protection as if you invested in a fund which is authorised by the FCA, and you may not be able to complain to the Financial Ombudsman Service or make a claim on the Financial Services Compensation Scheme if something goes wrong. You should only invest if you are prepared to lose all of your money.

There are a number of restrictions which may apply when securities relating to these AIFs are promoted to ordinary retail investors. For example, before some AIFs can be promoted you may be asked to elect to be treated as a professional investor or to certify that you are a sophisticated investor. You should not make an election or certification of this sort unless you satisfy the criteria to be treated as a professional or sophisticated investor. Agreeing to be treated as a professional or sophisticated investor could result in you being exposed to investments that are not appropriate for retail investors and may also affect your consumer rights. In such situations, you should consider seeking independent investment advice before doing so.
