ORDER

UPON AN APPLICATION made by the Trustee in Bankruptcy of the Defendants dated 23 July 2015

AND UPON Deputy Judge Mr David Halpern QC by his judgment delivered on 5 November 2014 approving the distribution plan proposed by the Financial Conduct Authority (the "**Court Approved Distribution Plan**")

AND UPON HEARING Counsel for the Claimant, Counsel for the Trustee in Bankruptcy of the Defendants and the Interested Party (in person).



IT IS ORDERED that:

- 1. Pursuant to Rule 11.2 of the Insolvency Rule 1986, notice of intention to pay a dividend in the bankruptcies of the Defendants shall be given by:
 - Posting the notices on the Claimant's website which can be found at http://www.fca.org.uk); and
 - (b) Publishing copies of the notices in the London Gazette.
- 2. Proofs of debt as identified be admitted into the respective bankruptcies of the Defendants and procedures to be followed, as indicated in Schedule 1 to this Order.
- 3. The Claimant, the Trustee in Bankruptcy of each of the Defendants and the Interested Party do each have liberty to apply on notice to each other.
- a. D. Anderson, D. Ernhardt, M. Anderson and C. Peacock ("the Close Relatives") do have liberty to apply to vary or set aside paragraphs 10 and 14 of Schedule 1 to this Order within 14 days of the Order being served on them.
 - b. A copy of this Order shall be posted on the Claimant's website which can be found at <u>http://www.fca.org.uk</u>
 - c. Any depositor in respect of any of the Defendant's schemes has liberty to apply to vary or set aside paragraphs 9 and 13 of Schedule 1 to this Order within 28 days of a copy of this Order being posted on the Claimant's website.
- 5. The Court Approved Distribution Plan be varied as follows:
 - a. The amount to be distributed under paragraph 2 is the amount the Trustee in Bankruptcy determines as being due to the Claimant in the First Defendant's Bankruptcy having taken into account the claims of trade creditors in the First Defendant's bankruptcy.
 - b. The amount to be distributed under paragraph 3 is the amount the Trustee in Bankruptcy determines as being due to the Claimant in the Second Defendant's Bankruptcy having taken into account the claims of trade creditors in the Second Defendant's bankruptcy.
 - c. Under paragraph 4:
 - The First and Second Defendants be omitted from the list of *qualifying investors* to receive a distribution from the Third Defendant's distribution.

- ii. The amount to be distributed under paragraph 4 is:
 - the amount the Trustee would have paid the Claimant in the Third Defendant's Bankruptcy as being due to the Claimant in the Third Defendant's Bankruptcy assuming the Trustee had not deducted from such amount the retention for claims by trade creditors in the First and Second Defendants' bankruptcies;

Less

- 2. the amount the Claimant would have distributed to the First and Second Defendants' Trustee in Bankruptcy as part of the distribution under paragraph 4 had [1] the First and Second Defendants been included in the distribution of the Third Defendant's just sum and [2] the Third Defendant's Trustee in Bankruptcy not deducted any retention for claims by trade creditors in the First and Second Defendants' bankruptcies.
- d. Appendices 1, 2 and 3 be replaced by Appendices 1, 2 and 3 contained in Schedule 2 to this Order.
- 6. In order that the Claimant may implement the Court Approved Distribution Plan, as varied, the Trustee in Bankruptcy is to provide the Claimant with its calculations of the proposed payment to the Claimant no less than 14 days in advance of any such proposed payment and to seek to agree such calculations with the Claimant.
- 7. There be no order as to costs save that the costs of the Trustee in Bankruptcy of each of the Defendants be paid as an expense of the bankruptcies.

The Trustee in Bankruptcy shall serve this Order on (1) the Claimant; (2) the Interested Party and (3) the Close Relatives.

SCHEDULE 1

Bankruptcy of Mr Pruthi

- 1. The FCA shall be admitted as a creditor for £89,806,577.
- 2. Neither Mr Anderson nor Mr Peacock have a claim in the Pruthi estate.
- 3. Claims by Mr Anderson and Mr Peacock against Mr Pruthi have already been included in the FCA claim against Mr Pruthi.
- 4. Any claim by any Investor that relates, whether directly or indirectly, to the Schemes will not be admitted as a claim in the Pruthi estate.
- 5. The estate of Mr Pruthi has net assets of approximately £830,000. The estates of Mr Anderson and Mr Peacock have no net assets.
- 6. By advertising the Notice of Intention to pay a dividend, the Trustee sets a bar date for proving for those that have not already submitted proofs. The Trustee will then pay a dividend to the FCA within 2 months of the bar date. Before paying the dividend, the Trustee will calculate the dividends due to close relatives and trade creditors of all three estates. A sum will be retained by the Trustee in the Pruthi estate to pay dividends to close relatives and trade creditors <u>of all three estates</u> out of funds in the Pruthi estate and to meet professional costs. The dividend to be paid to the FCA is anticipated to be not less than £800,000.This dividend is the totality of the amount to be paid to the FCA out of the Bankruptcies and will be applied by the FCA to compensate Investors is accordance with the Distribution Order.

Bankruptcy of Mr Anderson

- 7. The FCA shall be admitted as a creditor for £13,197,771.
- 8. The amount of the FCA claim will be used by the Trustee to calculate the dividend due to close relatives and trade creditors of Mr Anderson. However, no dividend will be paid to the FCA out of this estate as the FCA will have already received the totality of what it is to receive from the bankruptcies via the dividend paid out of the Pruthi estate.
- 9. Any claim by an Investor that relates, whether directly or indirectly, to the Schemes will not be admitted as a claim in the Anderson estate.
- 10. Close relatives shall be admitted as creditors for the following sums:

D.Anderson	£171,400
D Erhardt	£51,300
M.Anderson	£15,720

Bankruptcy of Mr Peacock

- 11. The FCA shall be admitted as a creditor for £11,658,677.
- 12. The amount of the FCA claim will be used by the Trustee to calculate the dividend due to close relatives and trade creditors of Mr Peacock . However, no dividend will be paid to the FCA out of this estate as the FCA will have already received the totality of what it is to receive from the bankruptcies via the dividend paid out of the Pruthi estate.
- 13. Any claim by an Investor that relates, whether directly or indirectly, to the Schemes will not be admitted as a claim in the Peacock estate.
- 14. C Peacock as a close relative is owed a negative sum and will not therefore be admitted as a creditor.
