ACTION

1. For the reasons set out in this Final Notice, the Authority hereby takes the following action against James Kirkwood.
2. The Authority issued to James Kirkwood the Decision Notice which notified him that for the reasons given below and pursuant to section 55J of the Act, the Authority had decided to cancel James Kirkwood's permission.
3. James Kirkwood has not referred the matter to the Tribunal within 28 days of the date on which the Decision Notice was issued to him.
4. Accordingly, the Authority has today cancelled James Kirkwood's permission.

DEFINITIONS

5. The definitions below are used in this Final Notice:
"the Act" means the Financial Services and Markets Act 2000;
"the Authority" means the Financial Conduct Authority;

“the Decision Notice” means the Decision Notice issued to James Kirkwood dated 26 January 2016;

“James Kirkwood’s permission” means the permission granted by the Authority to James Kirkwood pursuant to Part 4A of the Act;

“the Return” means the CCR007 return for the period ended 5 April 2015, which was due to be submitted to the Authority by 19 May 2015;

“the Threshold Conditions” means the threshold conditions set out in Schedule 6 to the Act; and

“the Tribunal” means the Upper Tribunal (Tax and Chancery Chamber).

REASONS FOR ACTION

6. On the basis of the facts and matters and conclusions described in its Warning Notice issued to James Kirkwood dated 30 December 2015 and in the Decision Notice, it appears to the Authority that James Kirkwood is failing to satisfy the Threshold Conditions, in that the Authority is not satisfied that James Kirkwood is a fit and proper person having regard to all the circumstances, including whether James Kirkwood managed his business in such a way as to ensure that his affairs were conducted in a sound and prudent manner.
7. This is because James Kirkwood has failed to comply with the regulatory requirement to submit the Return. James Kirkwood has not been open and co-operative in all his dealings with the Authority, in that he has failed to respond adequately to the Authority's repeated requests for him to submit the Return, and has thereby failed to comply with Principle 11 of the Authority's Principles for Businesses and to satisfy the Authority that he is ready, willing and organised to comply with the requirements and standards under the regulatory system.
8. These failures, which are significant in the context of James Kirkwood’s suitability, lead the Authority to conclude that James Kirkwood has failed to manage his business in such a way as to ensure that his affairs are conducted in a sound and prudent manner, that he is not a fit and proper person, and that he is therefore failing to satisfy the Threshold Conditions in relation to the regulated activities for which he had a permission.

DECISION MAKER

9. The decision which gave rise to the obligation to give this Final Notice was made by the Regulatory Decisions Committee.

IMPORTANT

10. This Final Notice is given to James Kirkwood in accordance with section 390(1) of the Act.

Publicity

11. The Authority must publish such information about the matter to which this Final Notice relates as the Authority considers appropriate. The information may be published in such manner as the Authority considers appropriate. However, the

Authority may not publish information if such publication would, in the opinion of the Authority, be unfair to James Kirkwood or prejudicial to the interest of consumers.

12. The Authority intends to publish such information about the matter to which this Final Notice relates as it considers appropriate.
