**TAKE NOTICE: The Financial Services Authority (the "FSA") of 25 The North Colonnade, Canary Wharf, London E14 5HS gives John Christopher Jordan ("Mr Jordan") and John Jordan Complete Mortgage Services Limited ("JJCMS") final notice about a decision to withdraw the approval granted to Mr Jordan in relation to JJCMS**

**1. ACTION**

- 1.1 The FSA gave Mr Jordan and JJCMS a Decision Notice on 8 September 2009 (the "Decision Notice") which notified them that for the reasons given below and pursuant to section 45 of the Financial Services and Markets Act 2000 (the "Act"), the FSA had decided to withdraw the approval granted to Mr Jordan in relation to JJCMS.
- 1.2 Mr Jordan and JJCMS were informed of their statutory right to make a reference to the Financial Services and Markets Tribunal, but they have not referred the Decision Notice to the Tribunal within 28 days of the date on which the Decision Notice was given to them. Accordingly, the FSA has today withdrawn the approval granted to Mr Jordan in relation to JJCMS.

**2. REASONS FOR ACTION**

2.1 The FSA has concluded, on the basis of the facts and matters and conclusions described in its Warning Notice dated 31 March 2009 and in the Decision Notice, that Mr Jordan not a fit and proper person to perform controlled functions because he fails to satisfy the criteria for fitness and propriety as set out in the Fit and Proper Test for Approved Persons in the FSA Handbook of Rules and Guidance.

2.2 Specifically, Mr Jordan has failed to comply with an award made by the Financial Ombudsman Service against his former sole trader firm, John Jordan Independent Financial Services.

### **3. DECISION MAKER**

3.1 The decision which gave rise to the obligation to issue this Final Notice was taken by the Regulatory Decisions Committee.

### **4. IMPORTANT**

4.1 This Final Notice is given to Mr Jordan and JJCMS in accordance with section 390(1) of the Act.

#### **Publicity**

4.2 Sections 391(4), 391(6) and 391(7) of the Act apply to the publication of information about the matter to which this Final Notice relates. Under those provisions, the FSA must publish such information about the matter to which this Final Notice relates as the FSA considers appropriate. The information may be published in such manner as the FSA considers appropriate. However, the FSA may not publish information if such publication would, in the opinion of the FSA, be unfair to Mr Jordan or JJCMS or prejudicial to the interests of consumers.

4.3 The FSA intends to publish such information about the matter to which this Final Notice relates as it considers appropriate.
