FINAL NOTICE

ACTION

- 1. For the reasons set out in this Final Notice, the Authority hereby takes the following action against PAL.
- 2. The Authority issued to PAL the Decision Notice which notified PAL that for the reasons given below and pursuant to section 55J of the Act, the Authority had decided to cancel PAL's Part 4A permission.
- 3. PAL has not referred the matter to the Tribunal within 28 days of the date on which the Decision Notice was given to PAL.
- 4. Accordingly, the Authority has today cancelled PAL's Part 4A permission.

DEFINITIONS

5. The definitions below are used in this Final Notice:

"the Act" means the Financial Services and Markets Act 2000;

"the Authority" means the Financial Conduct Authority;

"the Decision Notice" means the Decision Notice issued to PAL dated 27 October 2016;

"the Overdue Balance" means the amount owed by PAL to the Authority totalling £229.58, comprising: an invoice for annual fees and levies of £84.58 which was due for payment by 11 December 2014, and an invoice for annual fees and levies of £145.00 which was due for payment by 15 November 2015;

"PAL" means Pinks Agri Ltd;

"PAL's Part 4A permission" means the permission granted by the Authority to PAL under the Act;

"the Principles" means the Authority's Principles for Businesses;

"the suitability Threshold Condition" means the threshold condition set out in paragraph 2E of Schedule 6 to the Act;

"the Threshold Conditions" means the threshold conditions set out in Schedule 6 to the Act;

"the Tribunal" means the Upper Tribunal (Tax and Chancery Chamber); and

"the Warning Notice" means the Warning Notice issued to PAL dated 5 October 2016.

REASONS FOR THE ACTION

- 6. On the basis of the facts and matters and conclusions described in the Warning Notice, and in the Decision Notice, it appears to the Authority that PAL is failing to satisfy the suitability Threshold Condition, in that the Authority is not satisfied that PAL is a fit and proper person having regard to all the circumstances, including whether PAL managed its business in such a way as to ensure that its affairs were conducted in a sound and prudent manner.
- 7. PAL has failed to pay the Overdue Balance and it has not been open and cooperative in all its dealings with the Authority, in that PAL has failed to respond to the Authority's repeated requests for it to pay the Overdue Balance, and has thereby failed to comply with Principle 11 of the Principles and to satisfy the Authority that it is ready, willing and organised to comply with the requirements and standards under the regulatory system.
- 8. These failures, which are significant in the context of PAL's suitability, lead the Authority to conclude that PAL has failed to manage its business in such a way as to ensure that its affairs are conducted in a sound and prudent manner, that it is not a fit and proper person, and that it is therefore failing to satisfy the Threshold Conditions in relation to the regulated activities for which it has had a permission.
