TAKE NOTICE: The Financial Services Authority ("the FSA") of 25 The North Colonnade, Canary Wharf, London E14 5HS gives you final notice about a decision to cancel the permission granted to Redcliffe Associates Partnership Limited ("Redcliffe"), to carry on regulated activities.

#### 1. ACTION

The FSA gave Redcliffe a Decision Notice on 16 September 2005 ("the Decision Notice") which notified Redcliffe that for the reasons given below and pursuant to section 45 of the Financial Services and Markets Act 2000 ("the Act"), the FSA had decided to cancel the permission granted to Redcliffe pursuant to Part IV of the Act ("Redcliffe's Part IV permission").

Redcliffe has not referred the matter to the Financial Services and Markets Tribunal within 28 days of the date on which the Decision Notice was given to it. Accordingly, the FSA has today cancelled Redcliffe 's Part IV permission.

#### 2. REASONS FOR ACTION

On the basis of the facts and matters and conclusions described in its Warning Notice dated 10 August 2005 ("the Warning Notice"), and in the Decision Notice, the FSA has concluded that Redcliffe is failing to satisfy the threshold conditions set out in Schedule 6 to the Act ("the threshold conditions") in that it is failing to ensure that its business is conducted soundly and prudently and in compliance with proper standards. Redcliffe has also failed to comply with Principle 11 under which firms must cooperate with the FSA.

Specifically, since December 2004, Redcliffe has failed to reply substantively to correspondence from the FSA requesting information about the steps taken by Redcliffe to wind down its affairs and return money belonging to clients.

## 3. IMPORTANT

This Final Notice is given to Redcliffe in accordance with section 390(1) of the Act.

## **Publicity**

Sections 391(4), 391(6) and 391(7) of the Act apply to the publication of information about the matter to which this Final Notice relates. Under those provisions, the FSA must publish such information about the matter to which this Final Notice relates as the FSA considers appropriate. The information may be published in such manner as the FSA considers appropriate. However, the FSA may not publish information if such publication would, in the opinion of the FSA, be unfair to you or prejudicial to the interests of consumers.

The FSA intends to publish such information about the matter to which this Final Notice relates as it considers appropriate.
