# **FINAL NOTICE**

#### **ACTION**

- 1. For the reasons set out in this Final Notice, the Authority hereby takes the following action against Mr Hyde.
- 2. The Authority issued to Mr Hyde the Decision Notice which notified Mr Hyde that for the reasons given below and pursuant to section 55J of the Act, the Authority had decided to cancel Mr Hyde's Part 4A permission.
- 3. Mr Hyde has not referred the matter to the Tribunal within 28 days of the date on which the Decision Notice was given to him.
- 4. Accordingly, the Authority has today cancelled Mr Hyde's Part 4A permission.

#### **DEFINITIONS**

5. The definitions below are used in this Final Notice:

"the Act" means the Financial Services and Markets Act 2000;

"the Authority" means the Financial Conduct Authority;

"the Decision Notice" means the Decision Notice issued to Mr Hyde dated 26 July 2018;

"Mr Hyde's Part 4A permission" means the permission granted by the Authority to Mr Hyde pursuant to Part 4A of the Act;

"the Overdue Balance" means the amount owed by Mr Hyde to the Authority of £545 comprising: an invoice for administrative fee of £250 for late submission of a regulatory return, which had been due for payment by 12 August 2016; and an invoice for regulatory fees and levies of £295, which had been due for payment by 22 October 2016;

"the Principles" means the Authority's Principles for Businesses;

"the suitability Threshold Condition" means the threshold condition set out in paragraph 2E of Schedule 6 to the Act;

"the Threshold Conditions" means the threshold conditions set out in Schedule 6 to the Act;

"the Tribunal" means the Upper Tribunal (Tax and Chancery Chamber); and

"the Warning Notice" means the Warning Notice issued to Mr Hyde dated 4 July 2018.

#### **REASONS FOR THE ACTION**

- 6. On the basis of the facts and matters and conclusions described in the Warning Notice, and in the Decision Notice, it appears to the Authority that Mr Hyde is failing to meet the suitability Threshold Condition, in that the Authority is not satisfied that Mr Hyde is a fit and proper person having regard to all the circumstances, including whether Mr Hyde managed his business in such a way as to ensure that his affairs were conducted in a sound and prudent manner.
- 7. Mr Hyde has failed to pay the Overdue Balance and he has not been open and cooperative in all his dealings with the Authority, in that Mr Hyde has failed to respond to the Authority's repeated requests for him to pay the Overdue Balance, and has thereby failed to comply with Principle 11 of the Principles and to satisfy the Authority that he is ready, willing and organised to comply with the requirements and standards of the regulatory system.
- 8. These failures, which are significant in the context of Mr Hyde's suitability, lead the Authority to conclude that Mr Hyde has failed to manage his business in such a way as to ensure that his affairs are conducted in a sound and prudent manner, that he is not a fit and proper person, and that he is therefore failing to satisfy the Threshold Conditions in relation to the regulated activities for which he was granted a Part 4A permission.

## **DECISION MAKER**

9. The decision which gave rise to the obligation to give this Final Notice was made by the Regulatory Decisions Committee.
