# FINAL NOTICE

To: Strattons of Bournemouth Used Car Sales Limited

# ACTION

- 1. For the reasons set out in this Final Notice, the Authority hereby takes the following action against SBUCSL.
- 2. The Authority issued to SBUCSL the Decision Notice which notified SBUCSL that for the reasons given below and pursuant to section 55J of the Act, the Authority had decided to cancel SBUCSL's Part 4A permission.
- 3. SBUCSL has not referred the matter to the Tribunal within 28 days of the date on which the Decision Notice was given to it.
- 4. Accordingly, the Authority has today cancelled SBUCSL's Part 4A permission.

## DEFINITIONS

5. The definitions below are used in this Final Notice:

"the Act" means the Financial Services and Markets Act 2000;

"the Authority" means the Financial Conduct Authority;

"the Decision Notice" means the Decision Notice issued by the Authority to SBUCSL dated 6 August 2020;

"the Overdue Balance" means the outstanding sum of £733.97, owed by SBUCSL to the Authority comprising an invoice dated 23 October 2018 for £327.78 (which was due for payment by 22 November 2018) for regulatory fees and levies for the period 1 April 2018 to 31 March 2019; an invoice dated 9 April 2019 for £250 (which was due for payment by 9 May 2019) for a late submission of a regulatory return, which had been due to be submitted by 14 March 2019; and an invoice dated 31 July 2019 for £156.19 (which was due for payment by 31 August 2019) for regulatory fees and levies for the period 1 April 2019 to 31 March 2020;

"the Principles" means the Authority's Principles for Businesses;

"SBUCSL" means Strattons of Bournemouth Used Car Sales Limited;

"SBUCSL's Part 4A permission" means the permission granted by the Authority to SBUCSL pursuant to Part 4A of the Act;

"the suitability Threshold Condition" means the threshold condition set out in paragraph 2E of Schedule 6 to the Act;

"the Threshold Conditions" means the threshold conditions set out in Schedule 6 to the Act;

"the Tribunal" means the Upper Tribunal (Tax and Chancery Chamber); and

"the Warning Notice" means the Warning Notice issued by the Authority to SBUCSL dated 9 July 2020.

#### **REASONS FOR THE ACTION**

- 6. On the basis of the facts and matters and conclusions described in the Warning Notice, and in the Decision Notice, it appears to the Authority that SBUCSL is failing to satisfy the suitability Threshold Condition, in that the Authority is not satisfied that SBUCSL is a fit and proper person having regard to all the circumstances, including whether SBUCSL managed its business in such a way as to ensure that its affairs were conducted in a sound and prudent manner.
- 7. SBUCSL has failed to pay the Overdue Balance and it has not been open and cooperative in all its dealings with the Authority, in that SBUCSL has failed to respond to the Authority's repeated requests for it to pay the Overdue Balance, and has thereby failed to comply with Principle 11 of the Principles and to satisfy the Authority that it is ready, willing and organised to comply with the requirements and standards of the regulatory system.
- 8. These failures, which are significant in the context of SBUCSL's suitability, lead the Authority to conclude that SBUCSL has failed to manage its business in such a way as to ensure that its affairs are conducted in a sound and prudent manner, that it is not a fit and proper person, and that it is therefore failing to satisfy the Threshold Conditions in relation to the regulated activities for which it has had a permission.

## **DECISION MAKER**

9. The decision which gave rise to the obligation to give this Final Notice was made by the Regulatory Decisions Committee.

## IMPORTANT

10. This Final Notice is given to SBUCSL in accordance with section 390(1) of the Act.

## **Publicity**

- 11. The Authority must publish such information about the matter to which this Final Notice relates as the Authority considers appropriate. The information may be published in such manner as the Authority considers appropriate. However, the Authority may not publish information if such publication would, in the opinion of the Authority, be unfair to SBUCSL or prejudicial to the interest of consumers.
- 12. The Authority intends to publish such information about the matter to which this Final Notice relates as it considers appropriate.
