## Freedom of Information: Right to know request

I refer to your request for information under the Freedom of Information Act 2000 ("the Act"), for the following information:

- 1. "How many AIFMs are currently under investigation by the FCA for enforcement action?
- 2. What are they under investigation for?"

Before turning to your request, it is worth noting that we have defined Alternative Investment Fund Managers ("AIFMs") as firms that fall within the scope of the transparency reporting regime of the Alternative Investment Fund Managers Directive ("AIFMD"). This includes AIFMs that are UK domiciled and are either authorised by, or registered with, the FCA for the purposes of the AIFMD. It also includes AIFMs that are domiciled outside of the EEA but which have made a notification to the FCA to market one or more Alternative Investment Fund in the UK as permitted by the UK's AIFMD National Private Placement Regime. We have not limited the search to investigations in respect of those firms' AIFM business.

I confirm that we hold the information you have requested, based on the criteria set out above. In relation to point 1 of your request, as at January 2016 the FCA has open enforcement investigations into 2 firms that fall within the above criteria. With regard to point 2 of your request, the investigations are into mis-selling/customer care failings and systems and controls failings.

We note your previous request dated 23 December 2014 requesting the number of hedge funds or hedge fund managers under FCA investigation. In our response, we explained that, as the FCA does not have a specific case category for hedge fund managers, we focused our searches on firms who hold the permission of "Managing Investments" and firms who fall within the AIFMD. The scope of our response was not limited to only those firms that fulfilled both criteria. As such, our response of 67 open investigations correlated to 31 separate firms within a broader population than your current request. As with the current request, we did not limit the search by reference to firms' AIFMD activities.
