In respects to your fourth and fifth point. We combine the two to explain why we cannot respond to these parts of your request in full. The Whistleblowing Team share intelligence with other regulators and law enforcement bodies when it reasonably believes that some or all of the allegations should be considered by them. We also recommend that whistleblowers contact these bodies directly. All whistleblowing disclosures received by the FCA are reviewed and following our assessment, we provide the WB with feedback on their disclosures. The feedback we can provide is often limited due to the confidentiality restrictions we operate under.

External bodies are not required to, or expected to provide the FCA with an update or a conclusion to their enquiries. So unfortunately, we cannot provide a substantive response to your fifth point because we do not hold this data. We are however able to provide a list of regulators and law enforcement bodies we have shared intelligence with this year, where we reasonably believe the allegations received will be of interest to them.
