Thank you for your email of 5 October 2020, in which you asked for information in relation to Enforcement investigations.

We are handling your email as a request for information under the Freedom of Information Act 2000 (FOIA) and apologise for the delay in responding.

We have answered each question in turn.

a) How many enforcement investigations were opened against individuals, under the Senior Managers & Certification Regime (or, where relevant, the Senior Insurance Managers Regime) ("Investigations Opened"), in each of (i) 2016; (ii) 2017; (iii) 2018; (iv) 2019; and (v) between 1 January and 30 September 2020;
