Freedom of Information: Right to know request

Thank you for your emails of 7 December 2020 and 6 January 2021, the latter of which helpfully clarified your request. Full details of the request can be found in Annex A below.

We have processed your emails in line with the provisions of the Freedom of Information Act 2000 (FOIA) and our response is below.

When we wrote to you on 6 January 2021 we explained that as at 30th September 2020 only a small number of firms, specifically Benchmarking firms, were subject to Approved Persons Regime [APER], with around 800 individuals, most of which fell into the CF1, CF2, CF3 and CF4 functions. Most individuals who had previously held a Controlled Function had by this point been converted to the Senior Managers and Certification Regime [SMCR].

You clarified on 6 January 2021 that you would like the information for SMF functions under the SMCR rather than Controlled functions.

The following explanation should be taken into account when considering the information provided in Table 1 below:

- Table 1 provides a breakdown based on the approximately equivalent Senior Management Regime Functions [SMCR]: SMF 1 Chief executive function SMF 3 Executive director function SMF 9 Chair of the governing body function SMF 27 Partner function
- Note that SMF function holders have existed since March 2016 and there are some key dates where different populations were added to the SMCR regime which will help contextualise the numbers:
 March 2016: SMCR applicable to Deposit takers only (ie Banks, Building Societies and Credit Unions)
 December 2018: dual regulated insurance firms

December 2019: all solo firms except benchmarking firms and appointed representatives December 2020: Benchmarking firms.

• Please also note that the SMF9 (Chair of the Governing Body) function is different to the CF2 (Non-Executive Director) function in that SMF9 function holders can be executive or non executive (The Senior Managers and Certification Regime: Guide for FCA solo-regulated firms, pp 59-60)
