Thank you for your email of 2 February 2021, in which you asked about the gender divide in controlled functions. Please see Annex A for full details of your request.

We have processed your email in line with the provisions of the Freedom of Information Act 2000 (FOIA). Please accept our sincere apologies for the delay in responding.

Before we respond to your request we would like to explain that as at 30 September 2020 only a small number of firms, specifically Benchmarking firms were subject to Approved Persons Regime (APER), with around 800 individuals, most of which fell into the CF1, CF2, CF3 and CF4 functions. Most individuals who had previously held a Controlled Function had by this point been converted to the Senior Managers and Certification Regime (SMCR). Therefore, the numbers of individuals holding APER functions as at 31 December 2020 will be significantly lower than as at 31 December 2019.
