Overview

Legislative changes this month

The Handbook

- 1.1 On 20 June 2012 the FSA Board made changes to the Handbook to the Prospectus Rules (PR), Listing Rules (LR) and Disclosure and Transparency Rules (DTR), in order to implement the Prospectus Directive Amending Directive (FSA 2012/29).
- 1.2 On 28 June 2012 the FSA Board made changes to the Handbook in four instruments which:
 - make minor administrative corrections to the Handbook, none of which represents any change in FSA policy (FSA 2012/31);
 - update the appropriate qualifications list in the Training and Competence sourcebook (TC) (FSA 2012/32);
 - amend the liquidity rules in the Prudential sourcebook for Banks, Building Societies and Investment Firms (BIPRU) and the Supervision manual (SUP) (FSA 2012/33); and
 - implement changes to the Prospectus Rule sourcebook (PR) due to the Prospectus Regulation being amended by the European Commission (FSA 2012/34).
- These instruments are all listed in Annex A. 1.3

Changes outside the Handbook

1.4 There are no changes to material outside the Handbook this month.

Description of changes

The legislative changes referred to above are listed and briefly described in Chapters 2 and 3 (where appropriate) of this Notice.

Feedback on responses to consultations

- 1.6 Chapter 2 contains brief references to the consultative stages of the new legislative material made by the Board this month. Changes made to the Handbook in FSA 2012/31 were not consulted on as those amendments concerned copy-out changes of EU legislation. The other Handbook changes referred to in Chapter 2 were consulted on in the following documents:
 - CP11/28, UK implementation of Amending Directive 2010/73/EU Simplifying the EU Prospectus and Transparency Directives, (December 2011);
 - Chapter 3 of CP12/5, Quarterly Consultation Paper (No 32), (March 2012); and
 - CP12/8, Changes to the Training and Competence (TC) Sourcebook, (April 2012).
- 1.7 Feedback on the consultations in CP12/5 and CP12/8 are set out in Chapter 4 of this Notice. Feedback in relation to the other consultation was published in a separate policy statement.

- 2.4 In summary the amendments made this month are as follows:
 - addition of definitions of 'ESMA' and 'Rehabilitation Exceptions Orders';
 - deletion of the definition of 'investment services and activities' because it is duplicated by another definition;
 - change to the definition of 'designated investment business' and changes to IPRU(INV) 3.72R and to LR Appendix 1 to correspond more closely with the provisions of the Regulated Activities Order;
 - correction of an error in the definition of 'entering into a home reversion plan';
 - removal of a redundant cross-reference in PRIN 3.1.2G;
 - correction of errors in guidance, in COND 2.5.6G, FIT 2.1.3G and SUP 10 Annex 1G, in relation to the rehabilitation of offenders legislation; each jurisdiction in the UK has its own legislation on this and so the amendments make clear, for example, that there is a separate exemptions order in Northern Ireland rather than incorrectly stating that the only order is the one in England and Wales;
 - changes to the interpretative provisions of GEN 2.2.6G and GEN 2.2.9G to reflect the fact that other modules or parts of the Handbook (in this case the proposed new sourcebook CONRED and FEES Appendix 1) have their own self-contained Glossaries;
 - deletions within the Fees manual (FEES) of references (including the whole of FEES 4 Annex 3R) which refer to the FSA's former transaction reporting system;
 - addition to FEES of the Unauthorised Mutuals Registration Fees Rules, which previously stood outside the Handbook, this being consistent with our aim of bringing together in one place all the requirements relating to the payment of fees to the FSA;
 - changes to cross-references in COBS 4.12.1R, SUP 3.3.2R and COLL 8 Annex 1R;
 - a start has been made to remove expired transitional provisions throughout the Handbook; COBS, MCOB, BCOBS, CASS and MAR have been dealt with this month, and other modules will be dealt with in the same way over coming months;
 - correction of a transposition error from the MiFID Regulation within MAR 6.8.5EU;
 - removal, within SUP 16.12, of references to redundant data items;

- change to the FSA contact details within the retail investment adviser complaints alert form (SUP 10 Annex 9R);
- clarificatory changes to the Retail Mediation Activities Return (SUP 16 Annex 18AR) and the Notes (SUP 16 Annex 18BG);
- changes to the reporting requirements for small payment institutions to clarify how the value of transactions should be reported (SUP 16 Annex 28AD and SUP 16 Annex 29BG); the reason for the changes is that denominating field 2A in the reporting form in thousands has confused a significant number of small payment institutions (SPIs) and caused them to misrepresent the figure which has in turn led to the expenditure of time and resource, by both firms and the FSA, to remedy each instance;
- correction of an error in COMP 12.6.2AR introduced unintentionally in the Personal Pension Schemes Instrument 2006 (FSA 2006/28);
- correction, in COMP 16.4.1R, of an unintentional error in the Compensation Sourcebook (Deposit-taking Firms' Disclosure Requirements) Instrument 2012 (FSA 2012/27);
- changes within REC to make clear that certain information needs to be passed to ESMA as well as other European authorities; and
- changes within PR to implement the Prospectus Directive Amending Directive.

 - the deletion of the expired transitional provisions in COBS takes effect on 2 July 2012;
 - the change to COMP 16.4.1R comes into force on 31 August 2012;

- 2.31 In summary, the LR change will increase thresholds from 50,000 euros to 100,000 euros and the PR changes will include the following matters.
 - The Treasury amended the Financial Services and Markets Act (2000) (FSMA), to reflect the amendment of the Prospectus Directive⁶, by statutory instrument (SI 2012/1538), and relevant extracts from the amended version of FSMA will appear in the amended PR and will relate to the following matters:
 - requirements for a prospectus;
 - general contents of prospectuses;
 - summaries;
 - omission of information from prospectuses;
 - electronic publication of prospectuses;
 - supplementary prospectuses; and
 - certificate of approval.
 - Other amendments arising from the amendment of the Prospectus Directive are:
 - changes to the exemptions from publishing a prospectus for offers of securities to the public;
 - changes to the exemptions from publishing a prospectus for admission to trading on a regulated market;
 - changes relating to summaries;
 - changes relating to the format of the prospectus;
 - changes relating to incorporation by reference;
 - changes in relation to the filing and publication of prospectuses;
 - changes relating to the use of languages;
 - changes relating to the validity of the prospectus;

Amending Directive 2010/73/EU; Prospectus Directive 2003/71/EC.

- removal of the requirement for an annual information update;
- changes to the definition of a qualified investor and the removal of material relating to the qualified investors register; and
- changes to definitions in PR App 1.1.
- 2.32 A draft of the Treasury's statutory instrument appeared in PS12/9. The final statutory instrument (SI 2012/1538) contained two changes from the draft of the statutory instrument which appeared in PS12/9. These are:
 - the insertion of a new sub-section (a) into section 87Q(5) of FSMA together with additional wording at section 87Q(5)(c) of FSMA; and
 - the replacement of wording in section 96A(1)(c)(ii) of FSMA which refers to the annual information update, with the wording 'whose Home State is the United Kingdom'.
- 2.33 Following the laying before Parliament of SI 2012/1538, the following changes will be made to the Handbook:
 - changes to reflect s.87Q(5) FSMA in PR 3.4.2R; and
 - a consequential change to the defined term in the Glossary for 'person discharging managerial responsibilities'.
- 2.34 The DTR changes will include:

 - increasing thresholds from 50,000 euros to 100,000 euros; and
 - introducing new transitional provisions.

Therefore, it is intended to contribute to the overall efficiency of the regime.

- In Chapter 3 of CP12/58, we consulted on rule amendments to BIPRU 12, SUP 16 and 4.2 FSA050 and FSA052. The proposals comprised of:
 - an amendment to the guidance in BIPRU 12.3.7G dealing with reporting frequencies, to clarify that the higher frequency reporting is weekly for low-frequency liquidity reporting firms and simplified individual liquidity adequacy standards (ILAS) BIPRU firms;
 - amendments to SUP 16.12 and the applicable notes in relation to material currency reporting requirements for liquidity to ensure material currency reporting requirements apply only to FSA047 and FSA048; and

CP12/5, Quarterly Consultation (No 32), (March 2012).

- amendments to the SUP 16 Annex 24G reporting templates for FSA050 and FSA052.
- 4.3 We received two responses to the consultation. We have summarised the feedback below, together with our responses.

Responses to consultation

Amendment to BIPRU 12.3.7G

- 4.4 This guidance states that SUP 16 does not require daily reporting of certain data items absent a firm-specific liquidity stress or a market liquidity stress. The reference to daily reporting, whilst correct for standard ILAS BIPRU firms, is not correct for low-frequency liquidity reporting firms or simplified ILAS BIPRU firms which are required to report weekly during a firm-specific liquidity stress or market liquidity stress. We proposed to amend the guidance to make reference to the higher frequency reporting requirements of low-frequency liquidity reporting firms or simplified ILAS BIPRU firms.
- 4.5 We asked:
 - Q2.1: Do you agree with our proposals to amend BIPRU 12.3.7G?
- Both respondents agreed with this proposal and we intend to proceed with the amendments. 4.6
 - Amendments to SUP 16.12 notes for completing liquidity data items
- SUP 16 is supported by notes that contain additional information on how to complete the 4.7 liquidity data items. In particular, there are two notes within SUP 16 that cross-reference each other regarding our material currency requirements. We identified an omission in these notes that may incorrectly apply some of the currency requirements of data items FSA050 to FSA054. Therefore, we proposed to correct this omission.
- 4.8 We asked:
 - Q2.2: Do you agree with our proposal to amend the notes for SUP 16.12.5R, SUP 16.12.11R and SUP 16.12.15R?
- 4.9 Both respondents agreed with this proposal and we intend to proceed with the amendments.
 - Amendment to FSA050 and FSA052 data items
- FSA050 records details of an ILAS BIPRU firm's unencumbered assets eligible for inclusion 4.10 in its liquid assets buffer as defined in BIPRU 12.7. Line 23 of FSA050 is titled

- 'supranational(s)', as the only assets eligible under BIPRU 12.7 that can meet the definition of 'supranational(s)' are securities issued by designated multilateral development banks. We proposed to amend the title of line 23 to 'designated multilateral development bank(s)'.
- 4.11 FSA052 records details relating to the average transaction volume of, and prices which the firm pays for, certain wholesale liabilities. The data item includes the sentence 'wholesale liabilities (Raised during the week ending with the reporting date)'. We proposed to add 'month ending' to this text to clarify the sentence for firms that report FSA052 on a monthly basis.
- 4.12 We asked:
 - Q2.3: Do you agree with our proposal to amend FSA050 and FSA052?
- 4.13 Both respondents agreed with this proposal.
- 4.14 Internal consultation suggested simplifying the text shown on the FSA052 data item to ensure the change does not adversely impact the visual layout on the GABRIEL system. We will also add the following text to the special instructions section of GABRIEL - 'Firms on standard frequency liquidity reporting must report wholesale liabilities raised during the week. Firms on low frequency liquidity reporting must report wholesale liabilities raised during the month'. This does not require further consultation.

Cost benefit analysis and compatibility statement

- 4.15 In CP12/5, we set out the outcomes of our cost benefit analysis (CBA) and our consideration of the proposals in the context of our statutory objectives and principles of good regulation. The CBA and compatibility statement for the proposal remain unchanged from those published in CP12/5.
- We asked: 4.16
 - Q2.4: Do you agree with the cost benefit analysis?
- 4.17 Neither respondent raised any concerns regarding the CBA.

Equality and diversity issues

- 4.18 We continue to believe that these changes do not give rise to discrimination and are of low relevance on the equality agenda. We received no comments during consultation on any equality issues that respondents could foresee.
- 4.19 The changes made by this instrument are listed and described in paragraphs 2.22 to 2.24 of this Notice.

CP12/8, Changes to the Training and Competence sourcebook (TC)

Training and Competence Sourcebook (Qualifications Amendments No 6) Instrument 2012(FSA 2012/32)

Training and Competence sourcebook (TC)

- 4.20 As part of the Retail Distribution Review (RDR) we have committed to regularly updating our appropriate qualifications list.
- In Chapter 2 of PS11/19 and Chapter 3 of PS10/18¹⁰ we confirmed that we would publish 4.21 an appropriate qualifications list in the Training and Competence sourcebook (TC). We said that we would consult for one month each time we proposed that a new qualification should be added or removed from the appropriate qualification list.

Appropriate qualifications

- 4.22 In CP12/8, we proposed the following changes to the list of appropriate qualifications in TC Appendix 4E:
 - adding the following four qualifications to the appropriate qualifications lists:
 - Association of Certified International Investment Analysts (ACCIA)'s CIIA Qualification (when it is accompanied with appropriate qualification modules covering regulation and ethics, investment principles and risk and personal taxation);
 - Faculty or Institute of Actuaries Fellow or Associate or where the individual has passed all of the following modules CT1, CT2, CT4, CT5, CT6, CT7 and CT8;
 - ACI The Financial Markets Association's ACI Diploma meets full RDR requirements when it is accompanied with appropriate qualification modules covering regulation and ethics, investment principles and risk and personal taxation; for the following activities; and
 - Pensions Management Institute's Diploma in Regulated Retirement Advice; and
 - amending the details of the following two qualifications on the appropriate qualifications lists:
 - Chartered Institute of Securities and Investments (CISI)'s Financial Futures and Options paper of the Diploma from key (a) to key (d) indicating that this qualification will no longer remain on the qualifications lists after 31 December 2012; and

PS11/1, Distribution of retail investments: Delivering the RDR - professionalism Feedback to CP10/14 and CP10/22 and final rules,

- London Stock Exchange Full Membership Exams where the candidate holds three or four papers or holds both the Stock Exchange Practice and Techniques of Investment papers, to include other regional stock exchanges as merged with London Stock Exchange.
- 4.23 In CP12/8, we described the addition of the ACI Diploma with additional requirements as an amendment. However, the ACI Diploma without the additional requirements will continue to be an appropriate qualification until the end of the year in its own right. We now reflect this accurately as an additional qualification to the appropriate qualifications tables.
- 4.24 We did not receive any responses to our proposals. Therefore, we will amend the appropriate qualifications list as proposed.

Cost benefit analysis and compatibility statement

4.25 CP12/8 contained a cost benefit analysis explaining that the proposal does not incur any costs as it simply updates the list of appropriate qualifications. The effect of these changes on the cost benefit analysis and the compatibility statement remain as published in the CP12/8.

Equality and diversity issues

- 4.26 We continue to believe that these changes do not give rise to discrimination and are of low relevance on the equality agenda. We received no comments during consultation on any equality issues that respondents could foresee.
- 4.27 The changes made by this instrument are listed and described in paragraphs 2.9 to 2.11 of this Notice.
