1 Overview

Legislative changes this month

The Handbook

1.1 On 27 September 2012 the FSA Board made changes to the Handbook in two instruments which:

- create a mortgage market that is sustainable for all participants and that works better for consumers by reforming areas of responsible lending, distribution, disclosure, arrears management, non-bank lender prudential requirements and niche markets) (FSA 2012/46); and
- apply the relevant prudential requirements for banks and building societies (ie credit risk, credit risk mitigation and securitisation) to non-bank lenders, improve the loss absorbency of their capital and introduce a high level qualitative liquidity requirements (FSA 2012/47).
- **1.2** On 31 October 2012 the FSA Board made changes to the Handbook in eleven instruments which:
 - implement the EU Short Selling Regulation (SSR) which provides a common framework for regulating short selling across Europe (FSA 2012/58);
 - remove the Handbook definition of 'Connected Counterparties' and introduce Handbook guidance so that firms should, when assessing groups of connected clients, consider both third-party clients and counterparties that are connected to the firm itself (FSA 2012/59);
 - remove a grammatical error in the Prudential sourcebook for Banks, Building Societies and Investment Firms (BIPRU) (FSA 2012/60);

- implement changes made to the Insurance and Reinsurance Directives to take into account changes in the European index of consumer prices (FSA 2012/61);
- change the rules and guidance on pension transfer value analysis (TVA) assumptions in the Conduct of Business sourcebook (COBS) (FSA 2012/62);
- change the projection rates and amend an attendant rule (FSA 2012/63);
- require firms to provide information to consumers and their advisers so that they have a good understanding of the overall costs and benefits applying to different pension options (FSA 2012/64);
- clarify the requirements of Chapter 1A and Chapter 8 of the Client Assets sourcebook (CASS), and improve the Client Money and Assets Return (CMAR) and CMAR guidance so that firms will be able to manage their CASS oversight and reporting responsibilities more effectively and apply the rules in a more consistent manner (FSA 2012/65);
- implement Directive 2010/76/EU¹ (CRD 3) to collect data on remuneration practices and to transmit that data to the European Banking Authority (EBA) (FSA 2012/66);
- implement the Treasury's amendment to the Recognised Auction Platforms (RAPs) regulations (FSA 2012/67); and
- amend the 'Financial crime: a guide to firms' to include examples of good and poor practice drawn from two thematic reviews (FSA 2012/68).
- **1.3** These instruments are all listed in Annex A. Instruments FSA 2012/46 and FSA 2012/47 were made on 27 September 2012 and the changes will be summarised in Chapter 2 of this Notice

- **2.14** The large exposure (LE) regime is a directive based, non-risk sensitive backstop regime that limits a firm's ability to incur exposures to a single counterparty or a group of connected clients. The Directive definition of a 'group of connected clients' was implemented in a wider sense in BIPRU 10.3.8R.
- **2.15** The purpose of this instrument is to move closer to the Directive definition and to reflect the European Banking Authority's guidance on how this definition is to be applied in the context of exposures to structured finance vehicles.
- **2.16** This instrument comes into force on **2 November 2012**. Feedback on this consultation was published in a separate policy statement by the FSA.

Capital Requirements Directive (Handbook Amendments No 5) Instrument 2012 (FSA 2012/60)

2.17 Following consultation in Chapter 3 of CP12/11³, the Board has made the following changes in the Handbook:

- **2.18** The text of BIPRU 13.7.6R(2) provides three legal conditions that a contractual netting agreement must satisfy in order to be considered a valid agreement. Therefore, the existing text of 'or' in between the three conditions is incorrect and should be replaced with an 'and', so that firms contractual netting agreements satisfy all three legal conditions.
- **2.19** This instrument comes into force on **1 November 2012.** Feedback on this consultation is set out in Chapter 4 of this Notice.

- **2.21** In summary, these changes apply the relevant prudential requirements for banks, building societies (ie credit risk, credit risk mitigation and securitisation) to non-bank lenders, improve the loss of absorbency of their capital and introduce high level qualitative liquidity requirements.

Capital Requirements Directive (Handbook Amendment No 5) Instrument 2012 (FSA 2012/60)

Prudential sourcebook for Banks, Building Societies and Investments Firms (BIPRU)

- **4.2** In Chapter 3 of CP12/11, we consulted on a proposed minor amendment to rules on counterparty credit risk exposure netting requirements, to clarify the legal criteria that these netting agreements must meet.
- **4.3** BIPRU 13.7.6R sets out the requirements for recognition of contractual netting in assessing capital requirements. A firm must have a contractual netting agreement with its counterparty which, in the event of that counterparty's default, allows the firm to pay or to claim a single net amount in respect of all transactions under that agreement. In order to demonstrate that such netting would be recognised on the default of a counterparty, a firm must obtain legal opinions from all relevant jurisdictions, confirming that the netting would be recognised under the laws of those jurisdictions. The rule sets out the three categories of jurisdiction which are considered relevant. This rule is derived from the Banking Consolidation Directive 2006/48/EC (BCD)¹⁸.

Handbook changes

We propose to amend BIPRU 13.7.6R(2) by removing the words 'or' and linking (b) and (c) with 'and'. This should remove any ambiguity and make it clear that opinions must be obtained for each of the jurisdictions specified in paragraphs (a), (b) and (c). This amended wording is also consistent with the text of the original provision of the BCD.

Cost benefit analysis and compatibility statement

4.5 In Chapter 3 of CP12/11, we set out the outcomes of our cost benefit analysis (CBA) and our consideration of the proposals in the context of our statutory objectives and principles of good regulation. The CBA and compatibility statement for the proposal remain unchanged from those published in Chapter 3 of CP12/11.

Equality and diversity issues

- **4.6** We continue to believe that these changes do not give rise to discrimination and are of low relevance on the equality agenda.

4.8 Following reviews by the European Commission of certain amounts specified in the Insurance and Reinsurance Directives to take into account changes in the European index of consumer prices, we need to increase slightly the base capital resources requirement (BCRR) for insurers, along with the capital resources requirement (CRR) for general insurers, to continue to comply with those Directives.

Feedback to responses

- 4.9 All the respondents agreed with our proposed changes.
- **4.10** Two respondents reminded us that a consequential change would also be required to the wording of line 33 in Form 12 in Appendix 9.1 of IPRU(INS). This Form had been inadvertently omitted from Chapter 4 of CP12/11, but the appropriately amended Form has now been included in the Prudential Requirements for Insurers (Amendment No 6) Instrument 2012 (FSA 2012/61). We do not believe that this consequential change will have any significant effect on our previous cost benefit analysis.
- **4.11** One respondent highlighted the proposed change in the base capital resources requirement for the members of Lloyd's in aggregate in GENPRU 2.3.9R. We believe that this should be brought into line with the corresponding requirement for other firms, but we not believe that it will have any direct effect on the Society or its members.
- **4.12** One respondent questioned whether the assumed cost of capital set out in our cost benefit analysis (CBA) was appropriate for mutuals. There are very few mutuals that are expected to be impacted by these changes, and none would need to raise additional capital solely as a result of these changes.

Cost benefit analysis and compatibility statement

4.13 In Chapter 4 of CP12/11, we set out the outcomes of our CBA and our consideration of the proposals in the context of our statutory objectives and principles of good regulation. The CBA and compatibility statement for the proposal remain unchanged from those published in Chapter 4 of CP12/11.

Equality and diversity issues

- **4.14** We continue to believe that these changes do not give rise to discrimination and are low relevance on the equality agenda.
- **4.15** The changes made by this instrument are listed and described in paragraphs 2.24 to 2.27 of this Notice.

4.16 In Chapter 6 of CP12/11¹⁹, we consulted on our policy in respect of new FSA powers to impose a penalty on, or censure, a Recognised Auction Platform (RAP) where it has contravened certain directly applicable EU requirements set out in the Commission Auction Regulation (CAR).²⁰ We did not receive any formal responses to our consultation and have therefore not decided to change our policy approach. The only changes made to the rules are to add in the relevant dates and to reflect limited changes made by the Treasury to the underlying power in the Recognised Auction Platform Regulations 2011.

Cost benefit analysis and compatibility statement

4.17 In Chapter 6 of CP12/11, we set out the outcomes of our cost benefit analysis (CBA), our consideration of the proposals in the context of our statutory objectives and principles of good regulation. The CBA and compatibility statement for the proposal remain unchanged.
