1 Overview

Legislative changes

The Handbook

- 1.1 On 25 February 2010, the FSA Board made changes to the Handbook in four instruments which:
 - introduce a new penalty framework and increase disciplinary penalties in line with the FSA's credible deterrence strategy (FSA 2010/4);
 - provide certain retail authorised collective investment schemes (funds of alternative investment funds) with investment powers beyond those currently available to UCITS and non-UCITS retail schemes (FSA 2010/5);
 - make minor consequential changes to the Handbook to reflect the creation of a new specified investment 'Alternative Finance Investment Bonds' (FSA 2010/6); and
 - implement the final part of the Listing Review (FSA 2010/7).
- 1.2 These instruments are listed in Annex A.

Changes outside the Handbook

- 1.3 Changes have been made to:
 - the Perimeter Guidance manual (PERG) to explain how Alternative Finance Investment Bonds fit within the regulatory structure (FSA 2010/6); and
 - the Enforcement Guide (EG) as part of the new penalty framework referred to above (FSA 2010/4).

Description of changes

- 1.4 The legislative changes referred to above are listed and briefly described in Chapters 2 and 3 of this Notice.
- 1.5 The FSA reserves the right to make correctional or clarificatory amendments to the instruments made at the Board meeting without further consultation should this prove necessary or desirable.

Feedback on responses to consultations

- 1.6 Chapters 2 and 3 contain brief references to the consultative stages of the new legislative material made by the Board this month. The material referred to in those chapters was consulted on in the following documents:
 - CP08/4 Funds of Alternative Investment Funds (FAIFs): Feedback on CP07/6 and further consultation (February 2008);
 - CP09/19 Enforcement financial penalties (July 2009);
 - CP09/24 Listing regime review: Policy statement for CP08/21 and further minor consultation (October 2009);
 - Chapter 3 of CP09/25 Quarterly consultation (No 22) (October 2009); and
 - CP09/28 Listing Regime review: consultation on changes to the listing categories consequent to CP09/24 (November 2009).
- 1.7 Feedback on responses to the consultation in CP09/25 is set out in Chapter 4 of this Notice. Feedback on responses to the other consultations is being published separately.

- 2.9 Following consultation in CP09/19¹ this instrument amends the FSA's policy, as set out in the Handbook and in the Enforcement Guide, on the determination of the level of penalties for enforcement cases.
- 2.10 In particular it restructures the penalty framework into five steps to improve its transparency and consistency; the framework is based on the following principles:
 - that a person should not be able to benefit from wrongdoing;
 - that a firm or individual should be appropriately penalised for wrongdoing; and
 - that the financial penalty should be sufficient to deter others.
- 2.11 In addition, the instrument also:
 - provides for increased penalties in line with the FSA's credible deterrence strategy;
 - introduces an explanation of the FSA's approach in those cases where a person claims that a financial penalty will cause serious financial hardship; and

- makes minor changes to clarify the situations when the FSA is likely to publicise its actions in criminal investigations.

- 2.15 Following consultation in CP08/4² this instrument introduces rules to provide retail authorised collective investment schemes with investment powers beyond those currently available to UCITS and non-UCITS retail schemes, by creating retail "funds of alternative investment funds" (FAIFs).
- 2.16 The new Handbook provisions require FAIF managers to have a structured and thorough due diligence regime when investment is made in other collective investment schemes ("second schemes"). The rules provide a list of factors that the operator should consider before an initial investment and on an ongoing basis. These factors include requirements to determine:
 - 2 CP08/4 Funds of Alternative Investment Funds (FAIFs): Feedback on CP07/6 and further consultation (February 2008)

- that the second scheme complies with relevant legal and regulatory requirements;
- that the property of the second scheme is held in safekeeping by a third party which is subject to prudential regulation and independent of its investment manager;
- that the calculation of the net asset value of the second scheme and the maintenance of its accounting records is segregated from the investment management function; and
- that the second scheme is regularly audited by an independent auditor in accordance with international standards on auditing.
- 2.17 The effect of these provisions is to introduce a new sub-class of authorised collective investment scheme able to invest up to 100% of its assets into unregulated collective investment schemes. (Currently non-UCITS retail schemes are limited to a maximum of 20% in such unregulated schemes.) The new Handbook provisions also impose similar due diligence requirements on managers of qualified investor schemes investing in other collective investment schemes.
- 2.18 This instrument comes into force on 6 March 2010. Feedback on this consultation is being provided in a separate Policy Statement.

- 2.20 Following consultation in Chapter 3 of CP09/25³ minor changes have been made to the Handbook and PERG in order to reflect the insertion by HM Treasury into the Regulated Activities Order of a new category of specified investment "alternative finance investment bonds".
- 2.21 Alternative finance investment bonds, or "Sukuk", are Islamic bonds designed to replicate the economic function of conventional bonds and will be referred to as "alternative debentures" for the purposes of the Handbook. These debentures have become popular as the popularity of Islamic finance has grown. The legislative changes have been designed to align the treatment of alternative bonds with that of conventional bonds, because they have similar economic and risk characteristics.
- 2.22 This instrument comes into force on **26 February 2010**. Feedback on this consultation is set out in Chapter 4 of this Notice.

- 2.26 These changes represent the final stage of the FSA's review of the structure of the UK Listing Regime and follow CP09/24⁴ and CP09/28⁵. The new regime divides listed securities into two segments: Premium and Standard; each segment is then further broken down into a number of categories.
- 2.27 The changes amend the title of one of the Listing categories to 'standard listing (shares)' and introduce an additional category 'standard listing (miscellaneous securities)'. They also confirm the FSA's policy that Premium Listing will only be available to equity shares which meet all the super-equivalent requirements. Overseas issuers with securities in the Premium segment will be required to offer pre-emption rights. The changes also clarify that in order to be listed securities must be admitted to trading on a Regulated Market in the UK.
- 2.28 As a result of responses to the consultation we have put in place transitional arrangements; these include overseas Premium Listed companies not having to offer pre-emption rights to shareholders until 6 April 2011. This will allow time for the necessary authorities to be put in place.
- 2.29 This instrument comes into force on 6 April 2010. Feedback on the consultation is being published in a separate Policy Statement.

- 4.2 In Chapter 3 of CP09/25 we consulted on making amendments to the Perimeter Guidance manual (PERG) and certain other consequential changes, including changes to the Glossary of definitions and other relevant Handbook cross-references, as a result of the introduction of a new specified investment type 'alternative finance investment bonds' (AFIBs) under the Financial Services and Market Act 2000 (Regulated Activities) (Amendment) Order 2010 (the Statutory Instrument).
- 4.3 We received one response to this consultation which did not object to our proposals.
- 4.4 We have made some minor amendments to PERG, due to the fact that HM Treasury made some amendments to the Statutory Instrument after we published CP09/25. We have simply reflected these changes in the section in PERG where the statutory definition of an AFIB has been copied out. We have also added to PERG 2.6.12G that the exclusion under article 78(2) of the Regulated Activities Order is not applicable to government and public securities which amount to AFIBs. These changes do not affect the cost benefit analysis or compatibility statement which remain as published in the CP.

- 4.5 The Statutory Instrument which makes AFIBs a specified investment for the purposes of the Financial Services and Market Act comes into force on 24 February 2010.
- 4.6 The Handbook amendments made by this instrument are listed in paragraphs 2.19 to 2.22 of this Notice.
