1 Declarations of interest

1.1 The meeting noted there was a quorum present and proceeded to business.

2 Reports from the Chairs of Board Committees

- 2.1 The **noted** the verbal update from the Chair of the Joint FCA/PSR AuditCo Committee meeting held on 9 November 2023.
- 2.2 The Board **noted** the verbal update from the Chair of the RiskCo Committee meeting held on 9 November 2023.

2.3 The Board **noted** the verbal update from the Chair of the Joint FCA-PSR PeopleCo Committee meeting held on 16 November 2023.

3 Report from the PRA

3.1 Mr Woods briefed the Board on the business of the PRA that was of relevance to the FCA and draw attention to a recent speech by the Bank's Executive Director for Markets.

4 Report from the PSR

- 4.1 Ms Walsh briefed the Board on the business of the PSR that was of relevance to the FCA, including:
 - i. HM Treasury's "Future of Payments" review and New Payments Architecture.
 - ii. Interchange fees
 - iii. Open Banking
 - iv. The PSR Panel Chair recruitment
 - v. APP Scams.

5 Report from the Chief Executive

- 5.1 Mr Rathi briefed the Board on a number of topical issues, including:
 - i. Challenges faced by smaller banks in the current economic environment.
 - ii. The forthcoming NAO report and recommendations.
 - iii. The recent actions in the US in relation to Binance.
 - iv. Bank deposits and savings rates, and the Consumer Duty's obligation on firms to demonstrate that their products represent fair value.

v. The recent letter to the FCA from the Chancellor of the Exchequer and the Secretary of State for Work and Pensions, regarding the measures relating to pensions announced in the Government's Autumn Statement; and in particular, the role of the FCA's planned "Value for Money" rules in supporting this.

6 Sustainability Disclosure Requirements (SDR) and investment labels

- 6.1 The Board discussed the proposed rules around the SDR and investment labels. The Board considered and discussed the following areas:
 - i. The definition of "sustainability" and the ability of the labelling regime to evolve alongside any future changes in how "sustainability" is viewed.
 - ii. The link to other jurisdictions, particularly overseas funds which are marketed into the UK.
 - iii. Consumer testing, to ensure consumers understood the labelling and were able to act.
 - iv. Supervision and enforcement of the provisions; the Board received assurance regarding the skills and resources within the FCA available to support these new rules.
 - v. "Switching Costs".
- 6.2 The Board also discussed (i) ESG ratings and (ii) the SFDR.
- 6.3 The Board **approved** the final rules and guidance, and to publish the SDR and investment labels Policy Statement and anti-greenwashing guidance Consultation Paper on 28 November.

9.4 PaRCo recommended to the Board the approval of the publication of the commodity derivatives consultation at the meeting on 8 June 2023. The paper notified the Board of the CP publication in December. The consultation paper has incorporated the feedback and steers given by PaRCo in June – in particular use of an exec summary and foreword to explain the strategic intent of this work.

<u>Credit information Market Study (CIMS) final report and proposed remedies</u> package

9.5 To Board **noted** the proposed CIMS remedies package and implementation methods, as agreed by ERPC on 23rd October.

Board Effectiveness Review 2023 proposal
