

RegData user guide

Amending currencies

This user guide explains how to:

- amend currencies
- view previous currencies

By default, RegData reports are scheduled in a Reporting Currency of GBP (Pound Sterling).

Principal Users can change the Reporting Currency of their firm and, if applicable, set up additional Material Currencies for liquidity reporting.

Changes in currency will only apply to future submissions. Previously made submissions and scheduled data items with a Reporting Period End Date in the past cannot be changed.

1. Navigating to your currencies

Hover over Firm & User Administration, and then hover over Firm Administration. Click on **Manage Currencies**:

3. Changing your Material Currencies

Firms subject to the Liquidity Regime can set up a maximum of 3 additional Material Currencies per Reporting Basis. You can change your Material Currencies from the Current Currencies screen.
