Many people who transferred out of the BSPS were given poor financial advice and may be owed money. You could be one of them.

You could be owed money

We're now making advisers review the advice they gave you.

How it will work

Your adviser will write to you – give them any extra information they ask for.

They'll then review the advice they gave you – we've given them strict rules about how to do this and will be watching them closely.

If their advice was poor, they'll ask you for more information to work out if they owe you money.

If they owe you money they'll write to you with an offer.

If you accept it, they will pay you within 28 days.

If you're unhappy with their review or their offer, you can complain to the Financial Ombudsman.

What if your adviser no longer exists

If your adviser had gone out of business then you should make a claim with the Financial Services Compensation Scheme.

Os oes arnynt arian i chi byddant yn ysgrifennu atoch gyda chynnig.

Os byddwch yn ei dderbyn, byddant yn eich talu o fewn 28 diwrnod.

Os ydych yn anhapus â'u hadolygiad neu eu cynnig, gallwch gwyno i'r Ombwdsmon Ariannol.
