Freedom of Information: Right to know request

Thank you for your request under the Freedom of Information Act 2000 (the Act), for information about numbers of applications received by the Office of Fair Trading (OFT). For full details of your request please refer to Annex A.

Your request has now been considered and the relevant information is below.

In answer to your first question of your original request we can confirm 17,104 applications were received by OFT in 2010. Of these 16,185 were successful and 22 were unsuccessful. Please note a further 625 were withdrawn and 267 were made of no effect, with 5 open cases remaining.

Turning to request two where you asked about those applications that were received but not processed or not processed in time. You clarified in relation to applications not processed in time that you wanted information on applications which have a status other than issued, as at close on 31 March 2014. Further you also wanted information on applications for which an outcome was not reached by close on 31 March 2014 and applications which had not reached an outcome before the associated Guaranteed Decision Date (GDD).

Applications received but not processed:

As we have previously advised applications received by OFT can have one of five statuses:

- Open no outcome reached by close on 31 March 2014
- Issued the application was granted
- Withdrawn the applicant withdrew their application
- Made of no effect the applicant did not respond to a request for information within a statutory deadline
- Refused the application was formally refused following adjudication and any appeals.

Therefore applications that were not processed are those shown in the table below as either withdrawn or made of no effect.

Applications not processed in time:

We can confirm that there were 979 open cases as at 31 March 2014 that OFT passed over to FCA.

Following the implementation of the European Union Services Directive (EUSD) in 28 December 2009, an applicant would be informed of a Guaranteed Decision Date (GDD) once an application was deemed to be complete. If an application raised complex issues, then the directive allowed for a second GDD to be issued. Please note that tacit authorisation under the EUSD did not apply to the OFT's licensing regime for overriding public interest reasons relating to the health, safety and economic welfare of consumers who may use the services of unfit licence holders or be affected by their activities. This means that if a decision on a licence application is not made within the original or extended timeframe, the licence was not be deemed to have been granted.

The table below provides a breakdown of firms by year of receipt and their GDD status as at 31 March 2014. A firm is considered to have breached their GDD1 if they were determined, or were still open, after their GDD1 and no GDD2 had been issued. If a GDD2 has been issued, the same rule applies for this date.
